### Parallel Sessions

- Chairs are kindly requested to manage the **timing** of their sessions **strictly** so as to allow a smooth transition between and across sessions. The 30-minute-per-paper rules applies also to the few 2-paper sessions, to allow participants to switch sessions.
- Speakers may use the screen-sharing function to show the slides of their presentation.
